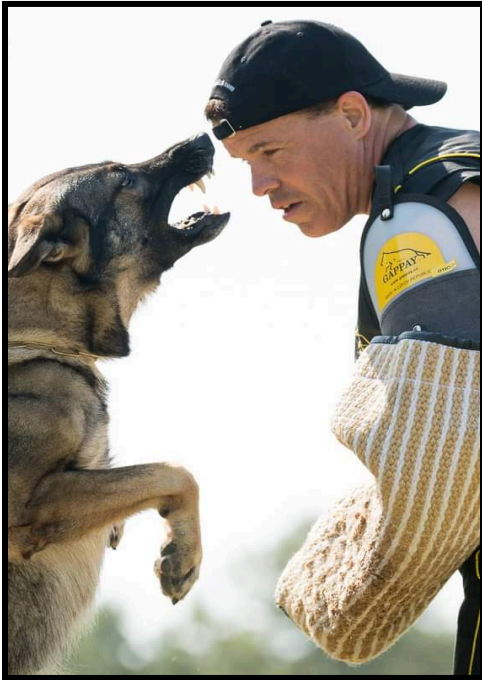




## Helper Seminar and USCA Helper Classification

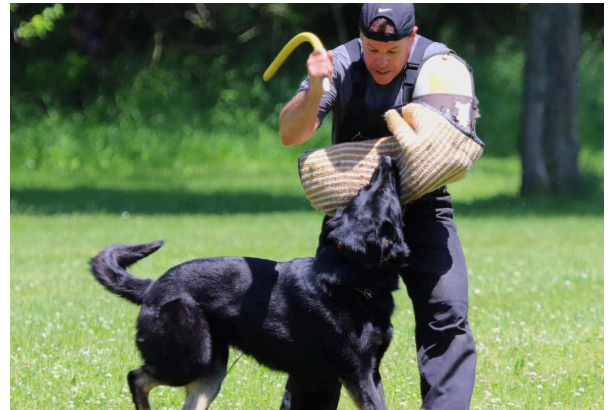
